**PROVINCIAL ASSEMBLY OF THE PUNJAB  
REPORT OF THE STANDING COMMITTEE ON LOCAL  
GOVERNMENT AND COMMUNITY DEVELOPMENT  
REGARDING THE PUNJAB LOCAL GOVERNMENT  
(AMENDMENT) BILL 2017 (BILL NO. 23 OF 2017)**

The Punjab Local Government (Amendment) Bill 2017 (Bill No.23 of 2017) was referred to the Standing Committee on Local Government and Community Development on 13 September 2017. The Committee considered the Bill in its meeting held on 5 October 2017.

3. Mr Kaiser Saleem, Additional Secretary, Local Government and Community Development Department and Mr Abid Raza, Deputy Secretary (Legislation), Law and Parliamentary Affairs Department represented their Departments. Mr Faiz-ul-Basit, Additional Secretary (Committees), Provincial Assembly of the Punjab functioned as Secretary to the Committee.

4. Mr Kaiser Saleem, Additional Secretary, Local Government and Community Development Department apprised the Committee about the aims and objects of the proposed Bill. He stated that it was necessary to amend the Punjab Local Government Act 2013 (*XVIII of 2013*) so as to extend the period of appointment of Administrators and to assign the function of providing sanitation, and collection and disposal of domestic, industrial and hospital solid waste to the District Councils and the Union Councils. He requested the Committee that the Bill, as introduced, may be recommended to be passed by the Assembly.

5. The Committee after hearing the Members, having view point of the Administrative Department as well as the Law and Parliamentary Affairs Department and discussing various points, unanimously decided to recommend that the Bill may be passed by the Assembly subject to the following amendments:-

**AMENDMENTS IN THE BILL**

**(1) PREAMBLE**

after the word "necessary" occurring in line 1, the word "further" be added.

**(2) CLAUSE 2**

the word "nine" occurring in line 3, be substituted by the word "twelve".

6. A copy of the Bill as introduced in the Assembly is at Annexure-A and a copy of the Bill as recommended by the Committee is at Annexure-B.

**THE PUNJAB LOCAL GOVERNMENT (AMENDMENT) BILL 2017**

*further to amend the Punjab Local Government Act 2013.*

It is necessary to amend the Punjab Local Government Act 2013 (*XVIII of 2013*) so as to extend the period of appointment of Administrators and to assign the function of providing sanitation and collection and disposal of domestic, industrial and hospital solid waste to the District Councils and Union Councils.

Be it enacted by the Provincial Assembly of the Punjab as follows:

**1. Short title and commencement.**— (1) This Act may be cited as the Punjab Local Government (Amendment) Act 2017.

(2) It shall come into force at once.

**2. Amendment in section 30 of Act XVIII of 2013.**— In the Punjab Local Government Act 2013 (*XVIII of 2013*), for brevity cited as 'the Act', in section 30, in subsection (3), for the word "six", the word "nine" shall be substituted and shall be deemed always to have been so substituted.

**3. Amendment in section 72 of the Act XVIII of 2013.**— In the Act, in section 72, in subsection (1):

- (i) in clause (t), the word "and" shall be omitted;
- (ii) in clause (u) for the full stop, the expression "; and" shall be substituted; and
- (iii) after clause (u), the following new clause (v) shall be inserted:  
" (v) provide sanitation and solid waste collection and sanitary disposal of solid, liquid, industrial and hospital waste."

**4. Amendment in section 77 of Act XVIII of 2013.**— In the Act, in section 77, for clause (l), the following shall be substituted:

- "(l) assisting Union Councils in the provision and maintenance of rural water supply schemes, public sources of drinking water, including wells, water pumps, tanks, ponds and other works for the supply of water and sanitation, and solid waste collection and sanitary disposal of solid, liquid, industrial and hospital waste;"

**5. Repeal.**— The Punjab Local Government (Amendment) Ordinance 2017 (XIII of 2017) is hereby repealed.

It is necessary further to amend the Punjab Local Government Act 2013 (*XVIII of 2013*) so as to extend the period of appointment of Administrators and to assign the function of providing sanitation and collection and disposal of domestic, industrial and hospital solid waste to the District Councils and Union Councils.

Be it enacted by the Provincial Assembly of the Punjab as follows:
