REPORT OF THE SPECIAL COMMITTEE NO. 4 REGARDING THE ISSUE OF LDA EMPLOYEES COOPERATIVE HOUSING SCHEME, THOKER NIAZ BAIG, LAHORE RAISED IN THE REPLY OF STARRED QUESTION NO.269 ASKED BY MRS AYESHA JAVED, MPA (W-317)

The issue of LDA Employees Cooperative Housing Scheme, Thokar Niaz Baig, Lahore raised in the reply of Starred Question No.269 asked by Mrs Ayesha Javed, MPA (W-317) was referred to Special Committee No.4 on 21 October 2014. The Committee considered the matter in its meetings held on 4 December 2014, 16 January, 21 April 2015, 27 April, 21 July, 30 September 2016, 10 January and 20 February 2017.

Mirza Mahmood-ul-Hassan, Registrar Cooperative Societies, Punjab, Lahore, Mr Mohsin Bukhari, Deputy Director, Law and Parliamentary Affairs Department and Mr Waheed Ahmed, CMP, Lahore Development Authority represented their Departments and Hafiz Muhammad Shafiq Adil, Special Secretary, Provincial Assembly of the Punjab functioned as Secretary to the Committee.

4. Mirza Mehmood-ul-Hassan, Registrar Cooperatives Societies, Punjab stated that due to efforts of the Special Committee, all the ghost members had been ejected from the Lahore Development Authority Employees Cooperative Housing Society, Thokar Niaz Baig Lahore. There were seven hundred sixty five genuine members of the Society out of which sixty five members were in litigation for the area of thirty three kanals. The approval for the map of the LDA Employees Cooperative Housing Society, Thokar Niaz Baig, Lahore was in process before the Lahore Development Authority.

5. The Convener of the Committee directed Registrar Cooperatives Society and Chief Metropolitan Planner, Lahore Development Authority to assist the management of LDA Employees Cooperative Housing Society, Thokar Niaz Baig, Lahore in getting approval of the Society map from Lahore Development Authority and also to assist the aggrieved persons, under litigation for getting possession of land.
6. The representatives of the LDA Employees Cooperative Housing Society, Thokar Niaz Baig, Lahore stated that they were highly obliged and thankful for the Mover and Hon'able Committee for their efforts in resolving the issue of the Housing Society.
7. The Mover and the Committee was satisfied with the steps taken by the Cooperatives Department, Lahore Development Authority and Revenue Department for resolving the issue of the Housing Society.
8. The Committee after hearing the Mover, Members, having view point of Cooperatives Department, Lahore Development Authority, Revenue Department and discussing various points, unanimously decided to dispose of the subject issue with the direction that Registrar Cooperatives Society and Chief Metropolitan Planner LDA would assist the management of LDA Employees Cooperative Housing Society, Thokar Niaz Baig, Lahore in getting approval of the Society map from Lahore Development Authority on top priority basis and also to assist the aggrieved persons, under litigation for getting possession of land.
